## 8. Conditions of participation:

- Applications have to be submitted until 10.08.2022 either to the Chief Arbiter Michał Wejsig (e-mail: wejszach@wp.pl) stating the group, name, Polish chess category, FIDE ranking, club and the date of birth or through the chessarbiter.com or chessmanager.com websites.
- The entry fee has to be paid until 10.08.2022 by bank transfer to the Silesian Chess Federation account no 97 1600 1462 1019 5563 7000 0001 Payment title: Wpisowe Ustron + group + name.
- The player who has submitted an application and payment on time shall arrive straight at the first round. The starting list and the confirmations of payment shall be regularly updated on the Festival's website https://www.chessustron.pl/.
- It is possible to pay the entry fee in cash. Then the fee is increased by PLN50 and payable in the Festival Office between 10.00 and 14.00 on 11.08.2023.

#### 10. Rules:

- In the tournament the current FIDE and PZSzach regulations shall apply.
- An appeal against an assistant arbiter's decision must be made to the Chief Arbiter of the tournament immediately after issuing the decision on payment of a PLN300 deposit at the Festival Office. The PLN300 deposit will be returned if the Chief Arbiter finds in favour of the party requesting the review. A continuation of the game means that the verdict of the assistant arbiter has been accepted. It is a condition of entry that players accept that, in the event of a dispute, the Chief Arbiter's decision is final.
- The failure of a player to appear within 30 minutes after the start of play will be treated as a default.
- Cell phones or other electronic communication devices may be brought to the playing hall on the condition that they are switched off and kept in a separate bag, handbag or backpack. Electronic devices that are switched off may be left at a designated place for the duration of the game on one's own responsibility.
- A player with a cell phone or other electronic communication device switched on in the playing hall shall lose the game.
- Players may request one half-point bye in rounds 1-6. The request must be submitted to the chief arbiter before the end of the last game in a given round at the latest.
- Tournament tiebreaks: 1. Buchholz CUT-1, 2. Buchholz, 3. Sonnenborn-Berger, 4. Progress, 5. The result of the match between the interested parties, 6. The number of wins, 7. The number of wins playing Black.

#### 11. Final remarks:

- The players or their guardians are responsible for their condition to play.
- The players shall insure themselves.
- The players, fans and parents are asked to keep peace and quiet in and around the playing hall.
- The players are obliged to observe special safety rules, according to legal regulations, including the recommendations of the Chief Sanitary Inspector and comply with current restrictions introduced with regard to preventing and reducing the spread of the SARS-CoV-2 virus.
- The organisers accept no responsibility for any loss, theft or accident during the tournament. Adult supervision will only be provided in the chess playing areas. Parents or guardians are responsible for their children during the tournament. The organisers and helpers are not able to take responsibility for any child's actions, or the actions of anyone that may affect your child.
